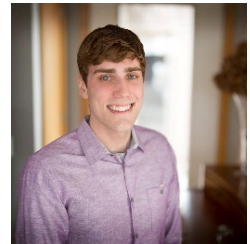
Installation (and the end of my Presidency) is taking place on September 21st at Rotary Garden Program starts at 9 AM!

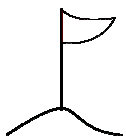

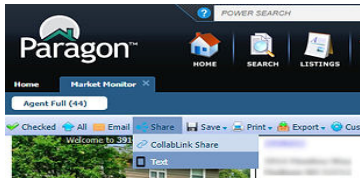

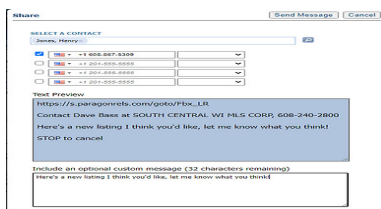
MLS INFORMATION:

***Text Listings from Paragon

Did you know you can text listings from Paragon? The text option can be found within the Share link when viewing a listing. The Share link is located within the blue menu bar, to the right of the Email button.



Listings can be sent via text to any contact you have saved within Paragon. There is an option to set up a contact on the fly after selecting to text. If you receive an alert stating your mobile number is not configured, simply click on the option given to Configure Settings, and enter your mobile phone number. You need to configure your mobile number just once. You also have the option to add a custom message. Once the text is sent, it will be recorded in the contact's Message History.



***Assessor Data / Public Records Resource

Did you know the assessor data for many municipalities is available online, for free? This provides an easy way to look up things like the number of bedrooms, bathrooms, finished square footage, year built, and more for a given property.

To locate this information, click **Tax** in the main Paragon menu and choose **Public Records Websites** from the dropdown. Select your county on the map, choose the appropriate municipality, and then search by address or parcel #. If you don't see your municipality listed, you can check AssessorData.org (for free) or purchase the complete property record for \$1.20 on AssessorData.com.

***Paragon Database Changes Completed June 15, 2023

The following additions/changes have been made to the listing data we collect within Paragon. Updated profile sheets can be found [here](#).

- The **Street Name** and **Street Type** (ex: Ave, St, Dr) have historically been included in one field. This has been split into two fields. The Street Type field is a pick list that contains non-abbreviated values (ex: Avenue, Street, Drive). This will help to maintain more uniformity with addresses both in our system and when the address flows to other databases. [Click here](#) for guidelines on address input.
- Fields for **Items Included** and **Items Excluded** have been added to the Lots & Acreage property class.
- High-speed internet options of **5G Installed** and **StarLink Installed** have been added to the Interior Features pick list.
- Smart home features of **Smart Doorbell**, **Smart Thermostat**, **Smart Garage Door Opener**, and **Smart**

Security Cameras have been added to the Interior Features pick list.

- Under the Condo property class, a feature for **Project Adjacent to Park/Public Land** has been added under Common Amenities, and a feature for **Unit Adjacent to Park/Public Land** has been added under Exterior Features.
- Under the Lots & Acreage class, a new feature for **Condo-Separate Amenity** has been added under the Type feature pick list. If you have a condo unit with no living space (ex: storage unit, garage/parking stall, pier) that is being sold separately, and is available to purchase by the general public, you can enter it under the Lots & Acreage property class and select this new Condo-Separate Amenity feature. It is required that you describe, in the first line of the public remarks, what is being sold so it is clear a unit of some type is for sale versus vacant land.
- A new waterfront feature for **Direct Access – Frontage Not Owned** has been added. This new feature should be used to identify properties that are contiguous to, and have authorized use of, shoreline owned by another entity, such as the Wisconsin River Power Company. These types of properties may no longer be identified by the Has Actual Waterfrontage feature. This change has been made at the request of the Wisconsin River Power Company.

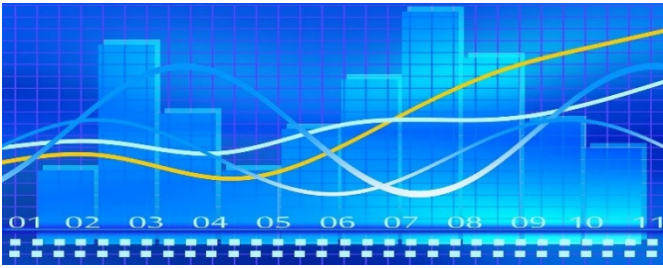

Rock County Housing Statistics

Madison, WI—As the prime season for home sales approaches, very tight inventories have kept sales low and put strong upward pressure on prices. Existing home sales in June dropped 20.4% compared to their levels in June of 2022, and the median price rose to \$304,000 in June 2023, which represents an 8.6% increase over the last 12 months. This is the first time the statewide monthly median price has exceeded \$300,000.

The tightening supply is a real problem for buyers. Market pressure normally peaks in the summer, with June being the highest volume month of the year. When there are fewer homes for sale, this drives prices up at a more rapid pace. While home price appreciation had moderated over the March-through-May period, rising at an annual rate of between 5.9% and 6.9%, June saw a spike in which the annual appreciation rate rose to 8.6%.

Joe Horning, 2023 Chair of the WRA Board of Directors, **TIGHT INVENTORY HURTS FIRST-TIME BUYERS:** “The state is a long way from a balance in the housing market at just 3.1 months of available inventory. We would need to nearly double our available inventory to get to a balanced market. The tightest supply of homes is in the \$350,000 or lower price range, which really hits the first-time buyers hard.”

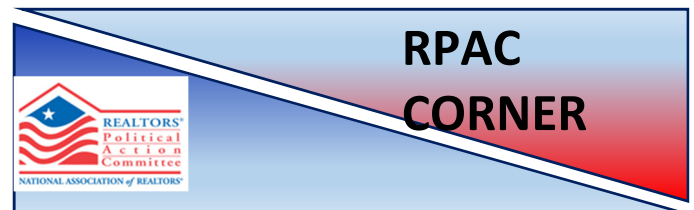
Michael Theo, WRA President and CEO tells us, **HIGHER MORTGAGE RATES AND HOME PRICES A PERFECT STORM FOR AFFORDABILITY:** “We’ve been tracking the Wisconsin Housing Affordability Index since 2009, and the June 2023 level of the index is the lowest we’ve seen to date. It’s not difficult to understand why. Home prices are up 8.6% since June 2022, and the 30-year fixed mortgage rate is higher by more than a percent compared to last year. Until we see some moderation in price appreciation and mortgage rates, affordability is not likely to improve.”

Dave Clark, Marquette University Economist and WRA Consultant, **INFLATIONARY PRESSURES CONTINUE TO SUBSIDE:** “The June inflation figures show headline inflation down a full percent to 3% from May figures, and the less volatile core inflation rate fell a half percent to 4.8%. Some analysts have noted that inflation was expected to be much lower in June because we are comparing to June 2022 prices that spiked inflation to 9.1%. Still, this is good news for the economy and hopefully it will lower inflationary expectations, which should lead to lower mortgage rates in the coming months.”

Rock County Housing Statistics—The median price for June 2023 is \$260,325 and for the month of June in 2022 it was \$250,000 that was an increase of +4.1% and the **Sales** for June 2023 is 244 and June of 2022 was 236 that was an increase of +3.4%. In June of 2023 there was 2.8 months of **inventory** and in June of 2022 there was 3.0 that was a -6.7% change. Average **days on the market** in June of 2023 was 60 and June of 2022 was 60 that was a 0.0% change.

Statewide Housing Statistics—The median price through June 2023 is \$280,000 and through June of 2022 it was \$260,000 that was an increase of +7.7%. The sales through June of 2023 is 28,205 and through June of 2022 was 37,503 that was a -24.8% change.

All county figures on sales volume and median prices are compiled by WRA and are not seasonally adjusted. Median prices are only computed if the county recorded at least 10 home sales in the quarter. Beginning in 2018, all historical sales volume and median price data from 2015 forward at the county level have been re-benchmarked using the Relitix system that accesses MLS data directly. Data prior to January 2015 is derived from the Techmark system that also accessed MLS data directly.

With statewide housing inventory levels at historic lows and median home prices continuing to rise, Wisconsin has a serious workforce housing shortage. Fortunately, Gov. Tony Evers recently signed into law a bipartisan package of bills intended to increase workforce housing in Wisconsin. This slate of bills will provide new financing tools to fund infrastructure investments, rehabilitate and repair older housing stock, convert units above main streets and vacant commercial buildings into available workforce housing, and limit the ability of “not in my backyard” (NIMBY) opponents to influence the development-approval process.

Hot Summer Days!

COLD CRAB DIP

½ c. crab, shredded
¾ c. sour cream
1 c. sharp Cheddar cheese
¾ c. mayonnaise
2 tsp. horseradish
¼ c. French dressing

Mix. Chill and serve with Ritz crackers

CUCUMBER CHIP DIP

1 lg. cucumber, finely dices & patted dry
1 (8 oz.) pkg. cream cheese, softened
2 T. milk
1 tsp. onion salt
1 sm. onion, finely diced

Press cucumber pieces dry with paper towel. Blend cream cheese with milk until very smooth. Stir in onion salt. Add dices cucumbers and diced onion. Serve with chips (your choice)

HAM CHEESE BALL

8 oz. cream cheese, softened
¼ c. mayonnaise
2 c. ground, cooked ham
2 T. parsley
1 tsp. minced onion
¼ tsp. dry mustard
¼ tsp. hot pepper sauce
½ c. chopped nuts

Beat cream cheese and mayonnaise until very smooth. Stir in next 5 ingredients and mix thoroughly. Cover bowl and chill well. Shape into balls, roll in nuts to coat and serve with crackers.
