**REALTOR® Party Mobile Alerts (RPMA)**

REALTOR® Party Mobile Alerts, NAR's advocacy texting platform, offers REALTOR® Associations and REALTORS® a way to stay connected directly from their cell phone or tablet. When a national or state legislative call for action is launched, subscribers get a short text message, containing information to take action. REALTORS® can sign up for REALTOR® Party Mobile Alerts using the form below or by texting the word **REALTORS TO 30644**.

**ATTENTION APPRAISERS**

This is a reminder that your CE is due every two years ending in the odd year #rs. Since this is 2023 yours are due this year.

**ANNUAL DUES ARE DUE**

The deadline for on-time dues has passed. If you have not paid your 2024 Annual Dues yet, you will need to add a \$100 late fee to the Local portion.

The Next Statewide Election is the 2024 Spring Election and Presidential Preference Vote. This will be on Tuesday, April 2, 2024. Need to know if you are registered or where your polling place is, [www.myvote.wi.gov](http://www.myvote.wi.gov) will give you all that information. Find your polling place, the hours and directions, what will be on the ballot, next local election info and learn about absentee voting if you can't get out to vote.

## MLS INFORMATION:

### \*\*\*Do Not Enter Without a Confirmed Appointment

The security of clients' properties is a top priority for all of us. If an agent accesses a keybox without a confirmed appointment, even if it is a vacant home, the agent and their broker may be assessed a fine of \$500 each. These fines double, and Supra eKEY access may be suspended for a second offense. These penalties are guidelines, and may be more severe depending on the circumstances. A seller can also bring trespass charges against any agent without a confirmed appointment. Before accessing a property, please double check the address & ensure you have permission.

### \*\*\* Accuracy of Date Listing:

The MLS works best for everyone when listing data is accurate. Agents are encouraged to utilize the assessor data as a source, as it provides an easy way to verify the number of bedrooms, bathrooms, finished square footage, year built, lot size, and more for a given property. Click the link in Paragon to locate assessor data by county or municipality.

If the assessor data is not available, or the listing agent believes another source is more accurate, there are also options for Appraiser, Blueprint, Builder, List Agent, or Seller. Other should only be selected when none of the other options apply, and should not be used as a workaround to independently verifying listing information. Regardless of the source, please double check the data you are entering for accuracy.

### \*\*\* Supra Hot Tip, Keybox access hours change with end of Daylight savings time:

Supra keyboxes come from the factory preset to open between the hours of 6:00 a.m. – 9:00 p.m. Central Standard Time, and shift to the hours of 7:00 a.m. – 10:00 p.m. during Daylight Saving Time. **So, with the end of Daylight Saving Time, they will open between the hours of 6:00 a.m. and 9:00 p.m.**

If you would like to change the access hours, or remove all time restrictions, you can do this for keyboxes you have added to your inventory. Once added, select the keybox and then select Program Keybox. Change the start or end time by clicking or tapping on the time. When done, you will need to select to Program the keybox. You will need to be near the keybox and have the shackle code to do this.

### \*\*\* Days on Market Explained

There are two types of days on market counts in the MLS:

- **DOM** = the number of days an **individual** MLS # has been actively marketed (Active, Offer-Bump, or Offer-Show status). The DOM resets each time a new MLS # is entered.
- **CDOM** = the **cumulative** number of days a property has been actively marketed. This includes the DOM from previous MLS #'s unless the property was off-market for at least 31 days between listings.

A few notes:

- In order to enter a new MLS #, a new listing contract must be secured (an amendment does not suffice). If a new listing contract is not obtained, the new listing will be deleted and a fine of \$50 will be assessed.
- Days on market do not accumulate while a listing is in Delayed, Withdrawn by Seller, or Offer-No Show status.
- To ensure a DOM count of 0, a listing must be entered **on** the list date.

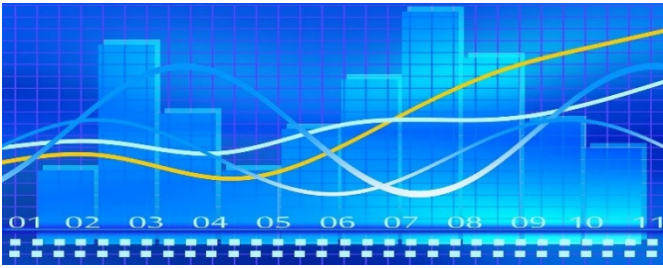

## Rock County Housing Statistics

Madison, WI—Mortgage rates continued to rise in October, softening demand pressure slightly as we move into the off-peak housing market. Existing home sales fell by just 7.2% in October 2023 compared to October 2022, which is the first time since August 2022 that the annualized decline in sales has been in the single digits. The median price rose 7.7% to \$280,000 over that same 12-month period.

Regionally, all but one region had sales decline by less than 10% over the past 12 months. Specifically, compared to October 2022, sales dropped between 6.1% and 6.3% in three regions – the North, Northeast and Southeast – and sales fell 8% in the South Central region and 9.7% in the West region. The Central region dropped 11.2% over the past year.

Mortgage rates averaged 7.62% in October, which is up from 7.20% in September, and up from 6.90% a year earlier.

This continues to be a strong seller's market with just 3.3 months of supply, which is well short of the benchmark of six months that signals a balanced market. Still there has been continued improvement in supply compared to a year earlier with just 2.7 months of supply.

**Joe Horning**, 2023 Chair of the WRA Board of Directors, **IMPROVEMENT IN NEW LISTINGS**: "The largest source of housing supply by far comes from sellers listing existing homes, so it is encouraging to see our new listings grow on a year-over-year basis. Hopefully this trend continues and leads to more affordable options for first-time buyers in the coming year."

**Michael Theo**, WRA President and CEO tells us, **OPPORTUNITIES IN OFF-PEAK SEASON**: "This is still a challenging market for buyers, but at least we are seeing some slight improvement on the supply side. This is a good time for buyers to remain engaged with their REALTOR®. Price pressure typically softens a bit in the off-peak season because there are typically fewer competitors during the late fall and winter months."

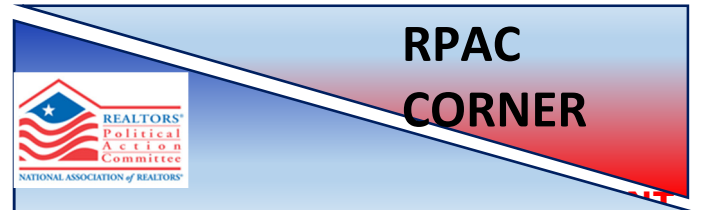
**Dave Clark**, Marquette University Economist and WRA Consultant, **ONGOING PROGRESS ON INFLATION**: "The actions of the Federal Reserve Bank have helped ease inflationary pressures, which will likely cause the Fed to pause its rate hikes for the remainder of the year. And, while the growth of real GDP was quite strong in the third quarter, there are signs that consumer expectations regarding the future are beginning to wane. This is actually good news as it suggests that the Fed won't need

to increase short-term interest rates to further slow the economy."

**Rock County Housing Statistics**—The median price for October 2023 is \$250,000 and for the month of October in 2022 it was \$244,950 that was an increase of +2.1% and the **Sales** for October 2023 is 197 and October of 2022 was 182 that was an increase of +8.2%. In October of 2023 there was 3.2 months of **inventory** and in October of 2022 there was 2.7 that was a +18.5% change. Average **days on the market** in October of 2023 was 64 and October of 2022 was 76 that was a -15.8% change.

**Statewide Housing Statistics**—The median price through October 2023 is \$287,000 and through October of 2022 it was \$265,000 that was an increase of +8.3%. The sales through October of 2023 is 54,045 and through October of 2022 was 67,571 and that was a -20.0% change.

All county figures on sales volume and median prices are compiled by WRA and are not seasonally adjusted. Median prices are only computed if the county recorded at least 10 home sales in the quarter. Beginning in 2018, all historical sales volume and median price data from 2015 forward at the county level have been re-benchmarked using the Relitix system that accesses MLS data directly. Data prior to January 2015 is derived from the Techmark system that also accessed MLS data directly.

## RECIPES

### CHRISTMAS CAKE

#### CAKE:

2 ½ c. flour  
1 c. buttermilk  
1 ½ c. vegetable oil  
1 tsp. baking soda  
1 tsp. vanilla  
2 oz. red food coloring  
1 ½ c. sugar  
1 tsp. unsweetened cocoa powder  
1 tsp. white vinegar  
2 lg. eggs

Preheat oven to 350°. Mix all ingredients well. Spray 3 (9-inch) cake pans with nonstick cooking spray. Divide batter into pans and bake for 20 minutes. Cool on wire racks in pans for 10 minutes, then turn out and cool completely.

#### FROSTING:

1 1/3 sticks butter, softened  
10 oz. cream cheese, softened  
1 lb. powdered sugar  
2 c. chopped pecans

Beat butter and cream cheese until smooth. Add sugar and beat until fluffy. Fold in 1 ½ cups pecans and frost cake. Top cake with another ½ cup chopped pecans. Refrigerate at least 1 hour before serving.

### CHRISTMAS WREATHS

These are pretty sweet, but wonderful pop of color on your cookie platter!

1 stick butter or margarine  
30 marshmallows  
¼ tsp. green food coloring  
½ tsp. vanilla  
1 ½ c. corn flakes  
Cinnamon candies  
Silver drop candies

Melt butter and marshmallows in top of double boiler. Add food coloring, vanilla and corn flakes, and blend. Shape gently into wreath forms with your fingers while mixture is still warm. Dip your fingers as necessary in cold water to prevent sticking. Decorate with cinnamon candies as holly berries and little silver drops for lights. Very pretty and quite tasty!
