
### A Note from your Association Executive:

## MLS INFORMATION:

### \*\*\* Maximizing Exposure for Your Listing

Here are a few tips to ensure your listing is being matched with the maximum number of buyer searches in Paragon:

- **Select all features that apply** - If your listing has a 2 car attached garage with an electric car charger, you would select the features "2 car", "attached", and "electric car charger" in the Garage feature category. Many buyer searches are set up based on specific features, so if your listing has a particular feature, but that feature is not selected, your listing will not come up as a match.
- **Check the mapping** – This can be verified & adjusted under Listing Maintain – Select an Action - Change GeoCode. This should be done for all new listings, but is particularly important for properties that do not have an established mailing address (ex: new construction or vacant land).
- **Utilize the price analysis tool** - Within Paragon, there is an easy way to see the number of potential buyers (Paragon contacts with saved searches) at the current list price, and if the price were changed. This functionality is available for partial listings, as well as live listings.
- **Note special property features in the remarks** – The remarks section of a listing is searchable, so if your listing has unique features that are not covered elsewhere in the listing data (ex: large garden space, apple orchard), be sure to mention these features in the remarks.

### \*\*\*New Paragon Feature – Easy CMA

Create a quick CMA report with just a few clicks with the new Easy CMA feature in Paragon. You'll find this option under the CMA icon.



Just add your subject property, and Easy CMA will find 10 comparables for you. You can also add others manually. Then click Generate CMA for a report you can print out or create a link to send.

### Reminder Regarding Drone Photos and Video

Photos and video taken via a drone, and loaded into the MLS, must be taken by a drone pilot who is certified to operate a drone for commercial purposes. When hiring a drone operator, please ask for their Remote Pilot Certificate number as issued by the FAA. If you are taking your own drone photos or videos for use within the MLS, which would be considered for commercial use, you must have your Remote Pilot's Certificate from the FAA. By loading a photo or video tour into the MLS system, members represent that they have the legal right to use and publish said photo or video for commercial use

## Rock County Housing Statistics

Madison, WI—Unmet demand and tight supplies continued to hamper home sales and drive up prices just ahead of the prime home buying season. May 2023 home sales fell by 21.5% compared to May 2022, and the median price rose 6.9% to \$294,000 over the last 12 months.

The inventory problem has not improved over the last year. A balanced market is characterized as six months of available supply, and there were 2.8 months of supply in May, unchanged from May 2022. This remains a strong seller's market. For the Wisconsin housing market to return to a balanced six-month supply, the available supply would need to increase by 111%, or 18,634 additional homes.

**Joe Horning**, 2023 Chair of the WRA Board of Directors, **POTENTIAL BUYERS MOTIVATED BUT WEAK SUPPLY REMAINS A PROBLEM**: “An aging baby-boom generation, now ready to downsize, is being replaced as the largest generation by millennials at their prime home-buying stage of life. While this demographic shift should translate into much stronger sales, higher mortgage rates have sidelined millennial buyers and have also kept some boomers from listing their homes. With new construction remaining low, our inventory problems persist.”

**Michael Theo**, WRA President and CEO tells us, **AFFORDABILITY A CHALLENGE FOR MILLENNIALS**: “The decline in affordability creates significant challenges for millennials, who are typically first-time buyers. They have smaller down payments than repeat buyers, and so higher mortgage rates have a bigger impact on their ability to compete for homes on the market. Hopefully both mortgage rates and price appreciation will continue to moderate so more buyers in this important generation can start accumulating wealth through homeownership.”

**Dave Clark**, Marquette University Economist and WRA Consultant, **SLOWER HOME PRICE APPRECIATION HELPS REDUCE INFLATION**: “The Fed's strategy of raising short-term interest rates to slow inflation continues to show progress. Headline inflation fell to 4% in May, which puts inflation at its lowest level since March 2021. This is due in no small part to the influence of housing costs in the Consumer Price Index (CPI). Owner-occupied housing alone has a weight of about 25% in the CPI. The fact that housing price appreciation has moderated has really helped our inflation numbers.”

**Rock County Housing Statistics**—The median price for May 2023 is \$259,300 and for the month of May in 2022 it was \$240,000 that was an increase of +8.0% and the **Sales** for May 2023 is 163 and May of 2022 was 212 that was a decrease of -23.1%. In May of 2023 there was 3.0 months of **inventory** and in May of 2022 there was 2.8 that was a +7.1% change. Average **days on the market** in May of 2023 was 58 and May of 2022 was 59 that was a -1.7% change.

**Statewide Housing Statistics**—The median price through May 2023 is \$275,000 and through May of 2022 it was \$254,963 that was an increase of +7.9%. The sales through May of 2023 is 21,141 and through May of 2022 was 28,720 that was a -26.4% change.

All county figures on sales volume and median prices are compiled by WRA and are not seasonally adjusted. Median prices are only computed if the county recorded at least 10 home sales in the quarter. Beginning in 2018, all historical sales volume and median price data from 2015 forward at the county level have been re-benchmarked using the Relitix system that accesses MLS data directly. Data prior to January 2015 is derived from the Techmark system that also accessed MLS data directly.

## RPAC CORNER



WRA has successfully presented new legislation to improve housing accessibility throughout the state.

Last week, Gov. Evers signed into law 5 historic bipartisan bills that will increase workforce and senior housing inventory in WI. Additionally, the legislature's Joint Finance Committee approved \$525 Million to fund these loan programs.

- Residential infrastructure development
- Rehabilitation and repair of older housing stock
- Updating of dilapidated units above main street commercial spaces.
- Conversion of vacant commercial properties for workforce housing.

In addition to the loan programs, the governor signed a bill that creates certainty and predictability in the development approval process, by requiring local governments to approve housing developments if they comply with local regulations. Furthermore, the bill streamlines the rezoning process and limits the ability of existing residents, or Not in My Backyard (NIMBYs) to oppose the development of new housing after a project has been approved.

These 55 bills are a once-in-a-generation opportunity to help spur housing inventory increases throughout Wisconsin.

7 c. water


2 c. sugar
