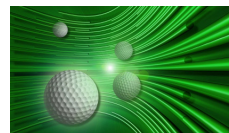

MLS INFORMATION:

***Update on Scheduling Showings Between Metro MLS, ROCK-GREEN MLS, SCWMLS

On April 8, Metro MLS moved to Aligned Showings and turned off ShowingTime within their MLS system. Metro agents are no longer able to click a button within their MLS system to schedule showings on ROCK-GREEN MLS, SCWMLS listings. Metro agents can contact you via phone or email to schedule showings manually, or they can access the ShowingTime system at <https://www.showingtime.com> or via the ShowingTime app and pull up ROCK-GREEN, SCWMLS listings by address or MLS number.

Within Paragon & WIREX, you are no longer able to click to schedule a showing on Metro listings (those prefixed by MM). Our intent is to add a button for the Aligned showings product on Metro listings within Paragon and WIREX, but we are waiting on programming from Aligned. We unfortunately do not have an ETA as to when this will be done.

Our Board of Directors continues to monitor progress of the Aligned product as a potential replacement for ShowingTime.

*** Searching by MLS Remarks

Did you know the MLS Remarks section of a listing is searchable? Within the Advanced Criteria section of your search options (at the bottom under Search), you will find the Remarks search prompt. Simply type in the work or words you are looking for.

For example, if your buyer would like a property that has a large garden space, type large garden and your search results will include properties for which the listing agent has included the words large garde4n in the remarks. You can also string together multiple words. For example, if your buyer would like a home on a secluded lot, you could type secluded (tab) private (tab) isolated.

Your search will bring back properties for which the listing agent has included any of these words in the remarks. Give it a try the next time you are looking for something there is not a specific search feature for. Also, when composing your remarks, make sure to mention special features not covered elsewhere in the listing features.

*** Walworth County Listings Now Imported from WIREX

Since June 2017, we have imported over 32,000 listings from other MLSs, via WIREX, directly into your SCWMLS database to make it easier for you to find them. These listings are located in the counties our SCWMLS members typically list and sell in. The MLS numbers for these listings are prefixed by 2 letters to make the MLS number unique, and to identify them as listings that originated in a different MLS system (ex: MM for Metro, NE for Northeast).

As of 5/13/24, we added Walworth County listings to these imports, for a total of [21 counties covered](#). This means that all current Walworth County listings (plus sold and expired listings with a list date of 1/1/24 and later) can now be found directly within the main SCWMLS database. It is no longer necessary to switch to WIREX to see listings in Walworth County

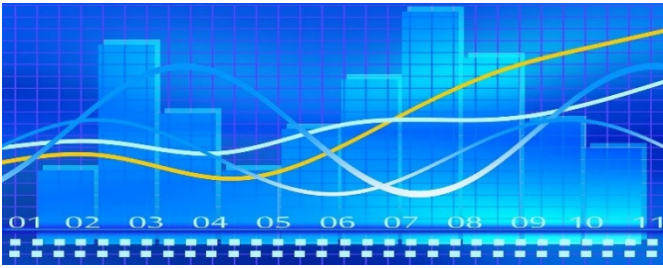

Rock County Housing Statistics

Madison, WI—Strong buyer demand combined with ongoing improvement in listings pushed existing home sales up dramatically and put pressure on prices. Compared to April 2023, home sales rose 25.7% in April relative to that same month last year, and the median price rose 6.4% to \$300,000 over that same 12-month period. On a year-to-date basis, sales were up 12%, and the median price increased to \$285,000, which is a 6.5% increase compared to the first four months of 2023.

The statewide inventory situation continues to improve. New listings of homes rose 13% in April 2024 compared to April 2023, and total listings were up 6.1% over that same period. Although the market remains a strong seller's market statewide with less than six months of available supply, the months of inventory improved 14.8%, from 2.7 months in April 2023 to 3.1 months in April 2024.

Rising prices and mortgage rates more than offset modest growth in family income, leading to a 10.1% decline in statewide affordability over the last 12 months.

Mary Jo Bowe, 2024 Chair of the WRA Board of Directors, **CONTINUED GOOD NEWS ON HOUSING SUPPLY**: "We've got a way to go before the market becomes balanced, but at least it's moving in the right direction. The growth trend in listings has really helped our sales this year, and it bodes well for robust growth this summer."

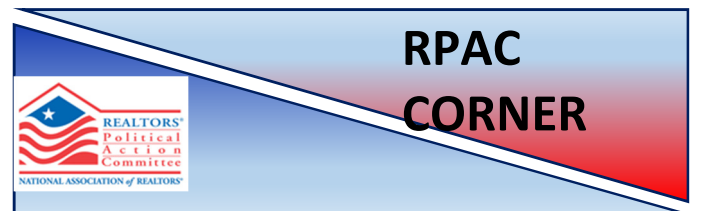
Tom Larson, WRA President and CEO tells us, **MILLENNIAL DEMAND RESILIENT EVEN AS MORTGAGE RATES RISE**: "There are significant unmet housing needs for millennial buyers, the oldest of whom are now in their early 40's. Even though average monthly mortgage rates have been increasing throughout 2024, millennials remain committed to homeownership, which is a big reason home sales have rebounded this year."

Dave Clark, Marquette University Economist and WRA Consultant, **MODERATING HOME PRICE APPRECIATION**: "A comparison of April housing prices in Wisconsin shows median prices up just over 40% since the pandemic hit in 2020. A lot of that increase took place between 2020 and 2022, when median prices rose almost 25% in total. In contrast, the last two years have seen 12-month home price increases of just 5.4% in April 2023, and only 6.4 in April 2024. Since homeownership expenses make up about one quarter of the overall weight of the Consumer Price Index, which is the index used to measure inflation, it's good to see some moderation in home price appreciation. Hopefully this will continue as the Fed works to meet its 2% inflation target."

Rock County Housing Statistics—The median price for April 2024 is \$288,000 and for the month of April in 2023 it was \$236,000 that was an increase of +22.0% and the **Sales** for April 2024 is 171 and April of 2023 was 139 that was an increase of +23.0%. In April of 2024 there was 3.1 months of **inventory** and in April of 2023 there was 3.0 that was a +24.0% change. Average **days on the market** in April of 2024 was 78 and April of 2023 was 72 that was a +8.3% change.

Statewide Housing Statistics—The median price through April 2024 is \$300,000 and through April of 2023 it was \$282,000 that was an increase of +6.4%. The sales through April of 2024 is 5,532 and through April of 2023 was 4,401 and that was a +25.7% change.

All county figures on sales volume and median prices are compiled by WRA and are not seasonally adjusted. Median prices are only computed if the county recorded at least 10 home sales in the quarter. Beginning in 2018, all historical sales volume and median price data from 2015 forward at the county level have been re-benchmarked using the Relitix system that accesses MLS data directly. Data prior to January 2015 is derived from the Techmark system that also accessed MLS data directly.

PRESIDENTIAL VOTING STATISTICS IN SWING STATE WISCONSIN | A handful of swing states usually decide U.S. presidential elections. And, according to the University of Virginia Center for Politics, the 2024 presidential election could be decided by four states currently rated as "toss-ups" where either side could win: Arizona, Georgia, Nevada and Wisconsin. Wisconsin continues to be a highly competitive battleground state in presidential elections, where tens of millions of dollars pour into the Badger State in the form of political advertising and individual contributions to the candidates. While swing states in past elections can be determined by looking at how close the vote was in each state, determining which states are likely to be swing states in future elections requires estimation and projection based on previous election results, polling, voter turnout and other circumstances such as the strength and weaknesses of the candidates involved. In Wisconsin, we are living in a highly competitive era of presidential politics.

RECIPES

IRISH CREAM CHEESECAKE with MIXED BERRIES

Begin preparing this luscious dessert the day before you plan to serve it.

CRUST:

1 c. graham cracker crumbs
3 T. sugar
3 T. butter, melted

FILLING:

3 (8 oz.) pkg. cream cheese, room temp.
1 c. sugar
2 tsp. vanilla extract
1 c. sour cream
1/3 c. Bailey's Original Irish Cream liqueur
4 lg. eggs

TOPPING:

1 c. sour cream
1/4 c. sugar
1 pt. strawberries, stemmed & halved
1/2 pt. raspberries
1/2 pt. blackberries or blueberries
Sugar

Crust: Preheat oven to 350°. Mix all ingredients in small bowl. Press crumb mixture onto bottom (not sides) of 9-inch springform pan with 2 3/4-inch high sides. Bake until brown, about 8 minutes. Transfer to rack and cool.

Filling: Using electric mixer, beat cream cheese, sugar and vanilla extract in large bowl until well blended. Beat in sour cream and Irish cream liqueur. Add eggs, one at a time, beating just until combined.

Pour filling over crust in pan. Bake until edges are puffed and center no longer "moves" when pan is shaken, about 50 minutes. Transfer cheesecake to rack and cool 10 minutes. Maintain oven temperature. Meanwhile, prepare Topping.

Topping: Mix sour cream and 1/4 cup sugar in bowl until smooth. Press down edges of top of cheesecake to flatten. Spoon topping over hot cheesecake. Bake 10 minutes. Transfer cheesecake to rack and cool. Cover and refrigerate overnight.

Combine fruit in large bowl. Season to taste with sugar. Release pan sides from cheesecake. Cut cheesecake into wedges and serve with berries.

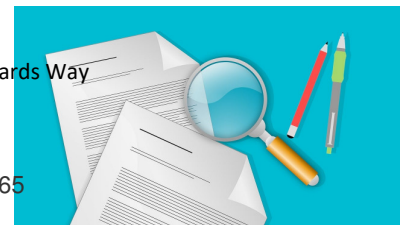
