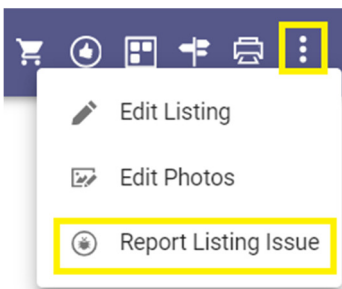

When viewing a listing in Paragon, the correction button can be found in the toolbar directly above the listing information:



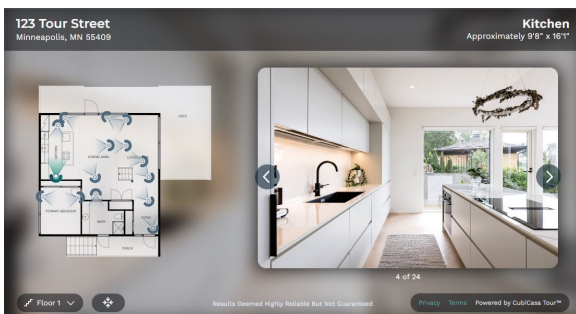
In Paragon Connect, it can be found within the three-dot menu in the upper right corner:

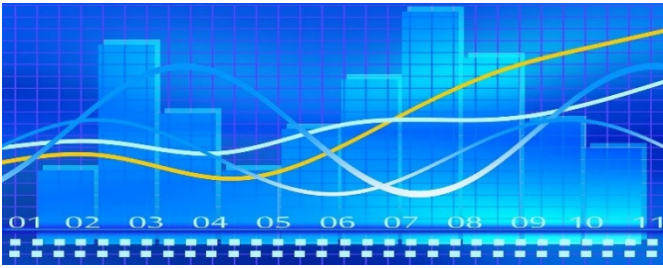

## Rock County Housing Statistics

Madison, WI—The existing home market saw fewer sales in September 2024 relative to that same month last year, with 8.7% fewer sales over the most recent 12-month period. The median price rose 6% to \$310,000 over that same period.

Although both total listings and new listings rose in September indicating a slight improvement in inventory levels, the housing market remained tight. With just 3.8 months of available supply, the existing home market continued to signal a strong seller's advantage, with supply well below the six-month benchmark that indicates a balanced housing market.

The trend of declining mortgage rates has improved affordability in the state. The average 30-year fixed mortgage rate fell to 6.18%, which is 102 basis points lower than the rate in September 2023. Combined with a slight increase in predicted median family income at just over a half percent since September 2023, the rate decline helped offset the 6% increase in the median home price. Overall, housing affordability improved 5.7% over the past 12 months.

**Mary Jo Bowe**, 2024 Chair of the WRA Board of Directors, **CONTINUED IMPROVEMENT ON MORTGAGE RATES:** "Mortgage rates are more than a percent lower compared to this time last year, and this is the fourth straight month they've fallen since averaging a little over 7% last May. This has really helped improve affordability in the state."

**Tom Larson**, WRA President and CEO tells us, **LISTINGS REMAIN AN ONGOING CHALLENGE FOR FIRST-TIME BUYERS:** "We did see an improvement in overall listings in September, but this is still a very challenging market for first-time buyers who are traditionally looking for starter homes at lower price points. There's a lot of unmet millennial demand, which unfortunately will keep pressure on prices and further shrink the inventory of starter homes."

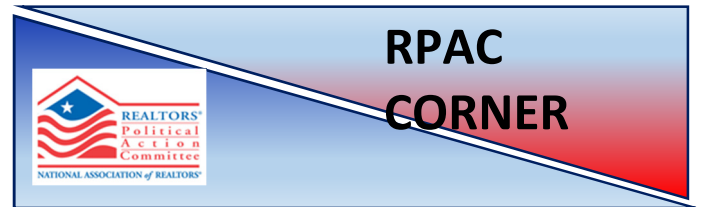
**Dave Clark**, Marquette University Economist and WRA Consultant, **SIGNALS ON THE ECONOMY ARE MIXED:** "The Fed's actions in September to lower short-term interest rates by a half percent sent a clear signal that it was concerned that recession was a greater risk than inflation. While core inflation did uptick slightly in September, the Conference Board's Leading Economic Indicator, which tends to trend downward as the economy weakens, fell again in September, which is the sixth consecutive monthly decline. The Fed meets two more times this year to decide whether additional cuts are warranted if inflation pressures

don't further strengthen, we can expect additional interest rate cuts this year."

**Rock County Housing Statistics**—The median price for September 2024 is \$270,000 and for the month of September in 2023 it was \$250,000 that was a +8.0% change and the **Sales** for September 2024 is 189 and September of 2023 was 198 that was an decrease of -4.5%. In September of 2024 there was 3.5 months of **inventory** and in September of 2023 there was 3.3 that was a +6.1% change. Average **days on the market** in September of 2024 was 80 and September of 2023 was 58 that was a +37.9% change.

**Statewide Housing Statistics**—The median price through September 2024 is \$310,000 and through September of 2023 it was \$292,500 that was an increase of +6.0%. The sales through September of 2024 is 5,817 and through August of 2023 was 6,370 and that was a -8.7% change.

All county figures on sales volume and median prices are compiled by WRA and are not seasonally adjusted. Median prices are only computed if the county recorded at least 10 home sales in the quarter. Beginning in 2018, all historical sales volume and median price data from 2015 forward at the county level have been re-benchmarked using the Relitix system that accesses MLS data directly. Data prior to January 2015 is derived from the Techmark system that also accessed MLS data directly.

# RECIPES

## Turkey Tricorns

This is an easy and wonderful solution to use up that leftover turkey!

2 T. butter  
1 T. flour  
½ cup milk  
1 T. instant minced onion  
1 tsp. chopped parsley  
1/3 c. chopped nuts  
½ tsp. monosodium glutamate  
2 c. diced, cooked turkey  
1 pkg. crescent rolls

Melt butter in a saucepan; blend in flour. Gradually stir in milk. Cook, stirring constantly, until thickens and begins to boil. Stir in onion, parsley, nuts MLS and turkey; mix well. Unwrap rolls. On each triangle, place ¼ cup of filling. Fold points of triangles together, pinching to secure. Place on ungreased baking sheet. Bake in 375° oven for 12 to 15 minutes, or until golden brown. Remove from oven. Serve with leftover gravy and cranberry sauce.

## Apple Crumb Pie

2/3 c. sugar  
2 T. flour  
¼ tsp. cinnamon  
¼ tsp. nutmeg  
4 c. peeled, cored and sliced apples  
1 Pet Ritz deep-dish pie crust shell (or make your own)  
½ c. flour  
¼ c. butter or margarine  
¼ c. firmly-packed brown sugar  
Cool Whip or whipped cream

Preheat oven and baking sheet to 400°. In a large bowl, combine sugar, flour, cinnamon and nutmeg; mix well. Add apple sliced and mix until apples are evenly coated; spoon into the pie shell.

**Crumb Topping:** in a small bowl, combine flour, butter and brown sugar until crumbly.

Sprinkle topping over the apples and place pie on baking sheet. Bake for 30 to 40 minutes. Allow to cool for 1 hour before serving. Top with whipped cream or Cool Whip.
